Dear San Bernardino County Restricted Materials Permit Holders/New Applicants and Pest Control Advisers.

RE: IMPORTANT REQUIREMENTS FOR YOUR 2021 RESTRICTED MATERIALS PERMIT

As we enter into the 2022 pesticide permit season, the San Bernardino County Agricultural Commissioner's Office wants to make you aware of some new information that will be required to be provided prior to issuing you a 2022 restricted materials permit. Title 3, California Code of Regulations (3 CCR), § 6426 requires a permit applicant (grower) and their pest control adviser to consider feasible alternatives to the use of restricted materials before applying for a restricted material permit (RMP) with the County Agricultural Commissioner (CAC). Title 3, California Code of Regulations 6426(a) states that: "Each licensed agricultural pest control adviser and grower, when determining if and when to use a pesticide that requires a permit, shall consider, and if feasible, adopt any reasonable, effective and practical mitigation measure or use any feasible alternative which would substantially lessen any significant adverse impact on the environment." While this specific requirement is directed at agricultural use, the general requirement to consider alternatives applies to all permits. To determine compliance with this requirement, we are asking you, the permit applicant, to identify the alternatives that you have considered. Please complete the Alternatives Considered for Restricted Materials Worksheet on the following page and submit that to our office with your other 2022 permit application/renewal documents.

When determining pest control alternatives to restricted materials, please consider the following:

- · Effectiveness (consider: broad control vs. selectivity, allowable applications per season, delivery mechanism, etc.)
- •Reliability (consider: weather effects, resistance development, effects of other species such as argentine ants when attempting to control mealybugs, etc.)
- Economic Factors (consider: cost-benefit of application, quality metrics, harvest timing, trade restrictions, etc.)
- •Environmental Factors (consider: how alternative could avoid or substantially lessen any significant environmental effect)
- •Social Factors (consider: nearby buildings or institutions, availability of labor and PPE, likeliness of drift, etc.)
- •Technological Factors (consider: delivery mechanism, type of sprayer available, acreage and topography, automation, etc.)
